**Sub: Revised Administrative Approval for the scheme "Improvement of Kultore Barrage Complex comprising section office, rest shade, etc. in Block & P.S Dubrajpur & Construction of office building of Zilladar at Albandha Section Complex within P.S Bolpur-Santiniketan, District Birbhum" bearing Scheme ID No. IW/CSP-15/2016-17, out of Core State Plan Budget Provision of this Department, subordinate to Demand No. 32, contained in B.P No. 20 during 2016-17.**

The undersigned is directed to say that administrative approval of original scheme was accorded vide this Departments No. 200-IB dated 21.09.2016 with the concurrence of Financial Advisor, I&W Department vide his U.O No. 90 dated 15.09.2016 at an estimated cost of ₹ **272.25 lakh** out of Core State Plan budget of this Department in the FY 2016-17.

The cost for the portion of "Construction of office building of Zilladar at Albandha Section Complex" was inadvertently omitted in the original administratively approved estimate. However, Chief Engineer (North), being the concerned Chief Engineer, has come up with a proposal for accordance of revised Administrative Approval of the instant scheme after incorporating the estimated cost of the said portion at a revised cost of ₹ 312.42 lakh.

Now, the undersigned is directed to convey the Revised Administrative Approval of the scheme "Improvement of Kultore Barrage Complex comprising section office, rest shade, etc. in Block & P.S Dubrajpur & Construction of office building of Zilladar at Albandha Section Complex within P.S Bolpur-Santiniketan, District Birbhum" at a revised estimated cost of ₹ **312.42 lakh (Rupees Three one two point four two lakh) only**, under Core State Plan Budget, Subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2016-17.
