I am directed to convey the accordance of Administrative Approval for **sharing of a one-time cost of ₹100.00 lakh (Rupees One zero zero point zero zero lakh)** in connection with the project '**Construction of 13 nos. boro bundhs at Begua Hana, Sankra, Chingra, Sosapota, Baligori, Kamdebchalk, Kalua & Gancha, Benejola & Raghunathpur, Bandipur, Gujrat, Chakvedua, Benejola and Gancha in Blocks Khanakul-I & II of District Hooghly**' bearing **Scheme ID: DM/CSP-220/2016-17** out of Core State Plan Budget of Irrigation & Waterways Department subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year 2016-17 upon fulfilment of following conditions:

- 1) The detailed estimate is may be technically sanctioned by a competent authority of Hooghly Zilla Parishad in terms of FD's Memo No. 5458-F(4) dated 27.06.2012.
- 2) Utilisation Certificate is required to be certified by competent authority at the end of the financial year or completion of work whichever is earlier.
- 3) No cost revision or additional cost would be borne by this Department.
- 4) Tender formalities as per provision of Rule 47 of WBSR as amended vide FD Notifications should be followed for selection of suppliers/contractors.

The aforesaid work is scheduled to be implemented by Hooghly Zilla Parishad as proposed vide Memo No. 1272/HZP dated 12.11.2016 of D.M & Executive Officer, Zilla Parishad, Hooghly.

One-time cost concurred by this Department relating to the said project would be chargeable under Core State Plan (Voted) budget of this Department, subordinate to Demand No. 32 as contained in BP No. 20 during 2016-17

Further to above, the entire sharing cost of ₹ 100.00 lakh is concurrently released vide this Department No. 436-IFS(W)/IW/P/IB/CSP-47/2016-17 dated 03.01.2017 through IFMS in favour of DM, Hooghly & Executive Officer, Hooghly Zilla Parishad as a one-time cost owing to the reasons cited by him.
