The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval for the project “*Separate 11 KV CESC electric supply of 750KVA demand load for Chowbhaga Pumping Station (Old) within KMC area, P.S Anandapur, District South 24-Parganas*” at an estimated cost of ₹ 224.00 lakh (*Rupees Two two four point zero zero lakh*) only out of Core State Plan (Voted) Budget of Irrigation & Waterways Department, subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2016-17. The following guidelines as applicable may be completed prior to implementation:

1. That all Tender formalities as per Provisions of Rule 47 of WBFR as amended vide FD Notification No. 5400-F(Y) Dated 25-06-2012 and other related orders in this respect will be followed for selection of the contractors/suppliers.
2. That the competent authority shall ensure that the executing authority has the authority to take up the work on the land in question like NOC from the respective Local Bodies etc. [Ref - FD Notification No. 10184-F(A-II) dated 13-12-2012].
