Sub: Revised Administrative Approval for the project "Construction of Ring Bundh of Sunderban Embankment for a length of 750.00 m [from Ch. 3.000 km to 3.450 km & 3.900 to 4.200 km] by concrete block pitching at Mouza Bagdanga (West) & Kusumtala (West) at the confluence of Muriganga & Bay of Bengal, Block & P.S.- Namkhana, Dist- South 24 Parganas under Kakdwip Irrigation Division" bearing Scheme ID No. IW/CSP-168/2015-16, out of Core State Plan Budget Provision of this Department, subordinate to Demand No. 32, contained in B.P No. 20 during 2016-17.

The undersigned is directed to say that administrative approval of original project was accorded vide this Departments No. 345(3)-IB dated 22.01.2016 with the concurrence of Financial Advisor vide his U.O No. 366 dated 22.10.2016 at an estimated cost of **Rs. 610.99 lakh** out of Core State budget of this Department in the FY 2015-16.

The above work was e-tendered and after 1st, 2nd and 3rd re-tenders were unsuccessful, 2 (two) valid bids were received in the 4th Re-Tender and the lowest rates quoted by the bidder was found @ 5.66% above tender value (BOQ). As such the instant case recommended by the Govt. Appointed Tender Committee and in consultation with FA and final recommendation of Head of this Department was submitted to the Finance (Audit) Department, Group-T in terms of Finance Department Memo No. 9754-F(Y) dated 03.12.2012 for their decision.

Finance (Audit) Department, Group-T has since concurred to the aforesaid proposal vide their Group-T U.O No. 0784/2016-17 dated 30.01.2017 and the corresponding Departmental order to this effect has been issued vide No. 386-IB dated 08.02.2017. The proposal for accordance of a formal revised administrative approval was then submitted to the Finance (Audit) Department, Group-F, the administrative group of this Department.

Finance (Audit) Department, Group-F has now accorded their concurrence to the proposed Revised Administrative Approval.

The undersigned is hence directed to convey the formal **Revised Administrative Approval** of the project "Construction of Ring Bundh of Sunderban Embankment for a length of 750.00 m [from Ch. 3.000 km to 3.450 km & 3.900 to 4.200 km] by concrete block pitching at Mouza Bagdanga (West) & Kusumtala (West) at the confluence of Muriganga & Bay of

Bengal, Block & P.S.- Namkhana, Dist- South 24 Parganas under Kakdwip Irrigation Division” at a revised estimated cost of **Rs. 634.10 lakh (Rupees Six Hundred Thirty-Four Lakh Ten Thousand) only**, under Core State Plan Budget, Subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2016-17.
