Sub: **Administrative Approval to the 'Apportioned Cost being 50% of total cost' relating to the project "Protection work at eroding right embankment of River Hooghly for a length of 650.00 m of Ghusuri under Ward No. 1 of Howrah Municipal Corporation, P.S Malipanchghara, District Howrah" under Howrah Irrigation Division, I&W Dte. bearing Scheme ID: IW/CSP-155/2017-18 out of Core State Plan Budget Provision of this Department, subordinate to Demand No. 32, contained in B.P No. 20 during the current financial year of 2017-18.**

The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval for the Apportioned Cost of ₹ 369.56 lakh (*Rupees three six nine point five six lakh*) only being the 50% of the total project cost of ₹ 739.11 lakh relating to the project "Protection work at eroding right embankment of River Hooghly for a length of 650.00 m of Ghusuri under Ward No. 1 of Howrah Municipal Corporation, P.S Malipanchghara, District Howrah" out of Core State Plan (Voted) Budget of Irrigation & Waterways Department, subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2017-18. The following guidelines as applicable may be completed prior to implementation:

1. That all Tender formalities as per Provisions of Rule 47 of WBFR as amended vide FD Notification No. 5400-F(Y) Dated 25-06-2012 and other related orders in this respect will be followed for selection of the contractors/suppliers.
2. That the instant project does not overlap with any other Central or State Sector Scheme undertaken by this or other Department of the State Government.
3. That the competent authority shall ensure that the executing authority has the authority to take up the work on the land in question like NOC from the respective Local Bodies etc. [Ref - FD Notification No. 10184-F(A-II) dated 13-12-2012].
4. Consent letter from Howrah Municipal Corporation under UD & MA Department, GoWB may please be obtained to bear balance 50% of the total cost.
