Sub: Administrative Approval of 7 nos. Schemes in connection with 'Improvement of drain and road under Domjur Block' out of Core State Plan Budget Provision of this Department subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2017-18 to be implemented by the Executive Officer, Domjur Panchayat Samity, Domjur, Howrah.

The undersigned is directed to accord Administrative Approval of 7 nos. of schemes having an aggregated estimated cost of ₹ 105.19 lakh (Rupees One zero five point one nine lakh) only as per the Annexure enclosed out of Core State Plan Budget Provision of Irrigation & Waterways Department, subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year 2017-18, provided,

- That all the Tender formalities as per Provisions of Rule 47 of WBFR as amended vide FD Notification No. 5400-F(Y) dated 25.06.2012 read with FD's Memo No. 4143-F(Y) dated 11.08.2014 regarding compliance of e-Tender norms and other related orders in this respect is to be followed for selection of the contractors/suppliers.
- That the projects do not overlap with any central sector scheme or state sector scheme undertaken by other Department of the State Government.
- That the tender issuing authority/tender accepting authority shall ensure the right to take up the work on the land in question like NoC from the respective Local Bodies (Ref. FD Notification No. 10184-F(A-II) dated 13.12.2012).

The aforesaid work is scheduled to be implemented by the Executive Officer, Domjur Panchayat Samity, Domjur, Howrah as **deposit work** on their part as per his Memo No. 1805 dated 13.07.2017.

Expenditure relating to the said schemes would stand debit to Core State Plan Voted Budget Provision of this Department, subordinate to Demand No. 32 as contained in BP No. 20 during the current financial year of 2017-18.

Further to above, 50% of the requisite amount will be allotted shortly in favour of the EO, Domjur Panchayat Samity, Domjur, Howrah through e-Bantan portal of IFMS during 2017-18.

This order is issued with the concurrence of Financial Advisor, Irrigation & Waterways Department vide his **U.O No. 430 to 436, all dated 04.08.2017** against each of the said 7 schemes as mentioned under column numbers 5 & 6 of Annexure.
