Administrative Approval was accorded to the following scheme vide this Department Memo No. 412-IB/ IW/P/IB-CSP-69/2017-18 dt. 02.11.2017 out of Core State Plan Budget of Irrigation & Waterways Department under Demand No. 32 during the current financial year of 2017-18.

Strengthening and protection to the left embankment of Kaliaghari river from 59.70 km to 59.95 km at Manipara for a length of 250.00 m in Block- & P.S. Moyna, Dist- Purba Medinipur (Scheme ID: IW/CSP-344/2017-18) – Administratively approved cost : Rs. 37.52 lakh

As per his report, the scope of work and length of protection to be undertaken have abruptly increased after passage of prolonged monsoon discharge during the current year. Consequently, the approved cost would be insufficient to cope up with the present requirement.

The Government in the Irrigation & Waterways Department has accepted his justifications referred above.

In the above context, the undersigned is directed to convey that the Administrative Approval of the above scheme is hereby withdrawn and may be treated as cancelled under Core State Plan of Irrigation & Waterways Department originally accorded during the current financial year of 2017-18.
