- That the projects do not overlap with any central sector scheme or state sector scheme undertaken by other Departments of the State Government.
- That the Administrative Department shall ensure that the executing authority has the authority to take up the work on the land in question like NOC from the respective Local Bodies etc. (Ref- FD Notification No. 10184-F(A-II) dt. 13.12.2012).
