CORRIGENDUM

In partial modification to this Department's Order No. 150(4)-IB/IW/P/IB-SDS-08/2018-19 dated 30.05.2018 relating to Administrative Approval for 27 projects under Capital Outlay of 'State Developments Schemes' voted Budget for 2018-19 of this Department, the undersigned is directed to say that:

1. The name of the scheme mentioned under Sl. 11 at page 2 of the Annexure bearing scheme ID No. IW/CSP-305/2018-19 should be read as "Protection to the eroding left bank of river Bidyadhari by providing 35 nos. spur including toe protection work for a length of 850 m at Gangnia within Block & P.S Deganga, District North 24-Parganas" instead of "Protection to the eroding left bank of river Bidyadhari by providing 35 nos. semi-permeable spur and dry brick pitching for a length of 850 m at Gangnia within Block & P.S Deganga, District North 24-Parganas".
2. Administratively approved estimated cost for the scheme "Re-sectioning of river Jamuna from ch. 9.0 km (upstream of Charghat Bridge) to ch 32.900 km (downstream of Ghonja Haspur Bridge) in Block & P.S Swarupnagar, Habra-I & Gaighata in the District North 24-Parganas" bearing Scheme ID No. IW/CSP-313/2018-19 at Serial No. 19, Col. 4 of the Annexure to the order should be read as Rs. 1571.97 lakh instead of Rs. 1486.87, and the target Financial Phasing for the year 2020-21 at Col. 7 should be read as Rs. 380.97 lakh instead Rs. 295.87 lakh.

All other contents of the said G.O remains unchanged.
