**Sub: Revised Administrative Approval for the project "Construction of RCC Retaining wall at the Down Stream end of Chandravaga Aqueduct on right side embankment at Ch. 400.00 of Mayurakshi Bakreswar Main Canal within the Block-Suri-I, P.S. Suri of Dist. Birbhum" bearing Scheme ID No. IW/CSP-223/2018-19, out of State Development Schemes Budget Provision of this Department, subordinate to Demand No. 32, contained in B.P No. 20 during 2018-19.**

The undersigned is directed to say that administrative approval of the original project was accorded vide this Departments No. 664(4)-IB dated 27.03.2018 with the concurrence of Financial Advisor, I & W Department vide his U.O No. 872 dated 27.03.2018 at an estimated cost of **Rs. 137.11 lakh** out of State Development Schemes budget of this Department in the Financial Year 2018-19.

Due to inadequate participation of bidders in the 1<sup>st</sup> Call, re-tender (2<sup>nd</sup> Call) for the work was invited in which, out of the 03 nos. of technically qualified bidders the agency named **PASSCON** with their offered rate of **3.86 % above the BoQ** emerged as the L1 bidder. The said L1 bid was accepted by the concerned Tender Inviting Authority in terms of **Finance Department Memo No. 975-F(Y) dated 03.12.2012**. As the revised estimated cost including 3% contingency over the tendered amount stands to Rs. 142.25 Lakh which is more than the originally administratively approved cost, the instant case was referred to the Financial Advisor of this Department for obtaining his concurrence.

Financial Advisor, I & W Department has since concurred to the aforesaid proposal vide his **U.O No. 77** dated **06/08/2018**.

The undersigned is now directed to convey the formal Revised Administrative Approval of the project "**Construction of RCC Retaining wall at the Down Stream end of Chandravaga Aqueduct on right side embankment at Ch. 400.00 of Mayurakshi Bakreswar Main Canal within the Block-Suri-I, P.S. Suri of Dist. Birbhum**" at a revised estimated cost of **Rs. 142.25 lakh (Rupees One Hundred Forty Two Lakh Twenty Five Thousand)** only inclusive of 3% contingency charges under State Development Schemes Budget of this Department, Subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2018-19 subject to observance of all rules and regulations as applicable.

Revised phasing of expenditure in respect of the said scheme is detailed below:
