Sub: **Administrative Approval of 3 (three) schemes bearing scheme ID Nos. SDS/Infra Gap/MI-17/2018-19 to SDS/Infra Gap/MI-19/2018-19 under Special Infrastructure Project Fund out of 'State Development Schemes' voted Budget for 2018-19 of this Department, subordinate to Demand No. 32, contained in B.P No. 20.**

Restoration of lost irrigation potential and creation of new irrigation potential by rejuvenation and improvement of existing medium/minor irrigation schemes have been under active consideration of the Department. The proposal of the Department for rejuvenation and improvement of identified 57 medium/minor irrigation schemes in different districts with an assessed gap funding of ₹ 164.28 Crore was approved by the State Level Committee on Infrastructure Projects, headed by the Chief Secretary, during its meeting on 20.04.2018. The State Finance Department also concurred their in-principle approval to bear the cost of the said schemes with an assessed gap funding of ₹ 164.28 Crore vide their U.O.No. 0146 dated, 26.04.2018. Subsequently, a proposal of the Department to take up rejuvenation and improvement of 27 medium/minor irrigation schemes at a preliminary assessed cost of ₹. 157.13 Crore, was accorded approval by the State Level Committee on Infrastructure Projects during its meeting on 13.06.2018 for implementation totally under Special Infrastructure Project Fund. The D.P.R s of 3 such schemes have been submitted to the Department and examined at different levels.

In view of above, the undersigned is directed to say that the Governor is pleased to accord Administrative Approval of 3 (**three**) **schemes**, at an aggregate estimated cost of ₹ **1578.29 lakh (Rupees One five seven eight point two nine lakh) only** under Special Infrastructure Project Fund of State Development Schemes (Voted) Budget of Irrigation & Waterways Department, subordinate to **Demand No. 32**, as shown in the Annexure to this Order for implementation during 2018-19 to 2020-21 subject to observation of all financial norms.

Phasing of expenditure contained in Annexure in respect of the said 3 schemes is as summarised below:

The expenditure relating to the said project would be debitible under the head of account 4701-04-101-099-53-V out of **State Development Schemes (Voted) Budget** of this Department, subordinate to Demand No. 32, as contained in B.P No. 20 during 2018-19.

He is requested to direct the concerned Superintending Engineers and Executive Engineers to take up execution of the said 3 schemes in conformity with the approved phasing of expenditure and to come up with the proposals of release of fund in Format-A (Modified), after accrual of financial liabilities against the said schemes in terms of guideline stated therein.

This order issues with the concurrence of the Financial Advisor, Irrigation & Waterways Department vide his **U.O. Nos. 107 to 109 Dated 13.09.2018** as mentioned against each of the said 9 schemes under Column 10 & 11 of the Annexure to this Order.
