He was already been requested to take necessary action after receiving any decision in the above mentioned matter vide this office memo under reference. Subsequently he had requested to the undersigned to communicate the decision of the Government regarding determination of seniority of Sri Ashis Kumar Shome, Barkandaz vide his memo.no.1188(16-3/78) dated 22.05.2017. But surprisingly it appears from the memo.no.288/PF-5 dated 23.05.2017 of Executive Engineer, Durgapur Mechanical & Electrical Division, I & W. Directorate alongwith copy of its enclosures that he has already been published a draft gradation list of Barkandaz vide his memo.no.1103(9) dated 16.05.2017 without any further instruction from this end and without any intimation to this office.

It is not clear from this end, why he has requested to communicate the decision in this regard while he has already published the draft gradation list of Barkandaz though he was requested not to do so vide this office memo under reference. The matter may be clarified from his end.

Draft gradation list of Barkandaz published vide his memo.no.1103(9) dated 16.05.2017 shall be corrected by inclusion the name of A.K. Shome as per Director of the Department vide their memo.no. 1364-IE/3M-15/2017 dated 22.05.17 (copy enclosed) and final gradation list of Barkandaz may be finalised immediately.

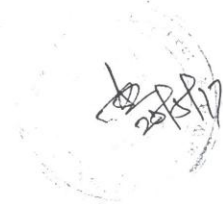
