Sir,

With reference to the subject and the memo. cited above, I am to inform you that some discrepancies as detailed below have been found in the instant medical bill submitted by Sri Barman, E.E. which are to be alleviated for according necessary sanction from this end.

- 1) The updated version of FORM 'D₃' of W.B.H.S., 2008 (copy enclosed) should be submitted. 'In certificate 1 of FORM D₃ the Specific procedure/Operation performed is to be mentioned. In certificate 3, number of beds is to be mentioned alongwith the License No. and validity of Licence of the non-empanelled Nursing Home. In the present form already submitted, the No. of bed has not been mentioned'.
- 2) The cost of medicines may be reimbursed only when the medicines are prescribed in their generic names in case of non-empanelled Health Care Organisation as per stipulation of WBHS'08. In the present HCO's bill medicines have been found to be prescribed in the brand names instead of generic names.

Under the circumstances, mentioned above you are requested to kindly take necessary action for rectification in respect of the above stated discrepancies, at your earliest convenience and resubmit the bill to this office for necessary sanction thereof.
