- a) To verify the age and academic qualification/documents before he/she is allowed to join, a report thereof should be submitted direct to the Irrigation & Waterways Department under intimation to the Director of Personnel & Ex-officio Chief Engineer, I&W Directorate.
- b) To ask the candidate to make a declaration of his/her date of birth in proper form and submit the same together with attested copies of his/her certificate of School Final/Higher Secondary or equivalent examination (one copy each of these documents) direct to Irrigation & Waterways Department and also to the Director of Personnel & Ex-officio Chief Engineer, I&W Dte. positively on his/her joining as Assistant Engineer (Civil).
- c) The oath of allegiance should be administered to the candidate on his/her joining as Assistant Engineer (Civil) in proper form by concerned Executive Engineer and to report to this effect should be submitted to Irrigation & Waterways Department as well as the Director of Personnel & Ex-officio Chief Engineer, I&W Dte.
