**CORRIGENDUM**

In partial modification of this Department's earlier No.12-W/2017-18 dated 08.08.2017 communicated vide No.2132(3)-IE/IE-100/2013 dated 08.08.2017 with annexes the Governor is hereby pleased, in the interest of public services, to make the following ammendments, as stated below :-

1. 'Kangsabati Canal Circle-II' shall be read as '**Kangsabati Circle-II**' at Para 4.(i) of page 2 of the main order.
2. Post of 'PA(Schedule-B)' shall be read as '**Steno Typist**' at Annex-8 (Sheet - 7/23, 12/23 and 14/23).
3. Post of 'Head Surveyor' proposed to be transferred from 'Subarnarekha Barrage Division' to '1 each in Lower Damodar Subdivision-I and Right Bank Irrigation Subdivision' shall be read as '**1 each in Lower Damodar Construction Division and Right Bank Irrigation Division**' at Annex-7 (Sheet - 8/14).
4. Post of 'Barkandaz' shall be read as '**Barkandaz / Barkandaz-cum-Guard**' at Annex-9 (Sheet - 3/4).
5. Post of 'Work Khalasi & Gauge Khalasi' shall be read as '**Gauge Khalasi**' at Annex-9 (Sheet-3/4).
6. Post of '**Work-Charged Gauge Khalasi**' shall be added at B: Other Category Staff, Sanctioned strength shall be read as '0', existing strength shall be read as '2', Name of the office to which posts and incumbents to be transferred shall be read as '**Malda Irrigation Division**', No of sanctioned posts to be transferred shall be read as '0' and No. of incumbents proposed to be transferred shall be read as '2' at Annex-9 (Sheet-4/4).
7. Post of '**Work-Charged Night Guard**' shall be added at B: Other Category Staff, Sanctioned strength shall be read as '0', existing strength shall be read as '2', Name of the office to which posts and incumbents to be transferred shall be read as '**Malda Irrigation Division**', No. of sanctioned posts to be transferred shall be read as '0' and No. of incumbents proposed to be transferred shall be read as '2' at Annex-9 (Sheet-4/4).
8. Post of '**Work-Charged Plumber**' shall be added as B: Other Category Staff, Sanctioned strength shall be read as '0', existing strength shall be read as '1' and

- Remarks shall be read as 'Existing incumbent may be transferred to North Dinajpur Irrigation Division' at Annex-8 (Sheet-5/23).
9. Post of 'Work-Charged Khalasi' shall be added as B: Other Category Staff, Sanctioned strength shall be read as '0', existing strength shall be read as '3' and Remarks shall be read as 'Existing incumbent may be transferred to North Dinajpur Irrigation Division' at Annex-8 (Sheet-5/23).
10. No of posts in the category under UDA and LDA column shall be read both as '0' instead '1' and 'Note-3' under LDA column shall be read as 'Note-1' for office of Chief Engineer (Teesta Barrage Project) at Siliguri, District Darjeeling at Annex-4 (Sheet-1/1).
11. Total under column of UDA and LDA shall be read as '30 + 1(Note-1) + 1(Note-4) Total = 32' instead of '29 + 1(Note-1) + 1(Note-4) Total = 31' and '27 + 1(Note-1) + 1(Note-5) Total = 29' instead of '26 + 1(Note-1) + 1(Note-5) Total = 28' respectively for office of the CE(South), CE (D&R) and DP & Ex-Officio CE at Annex-4 (Sheet-1/1).
12. Existing strength of Contractual Data Entry Operator (DEO) shall be read as '1' instead of '0' at Annex-7 (Sheet- 6/14).

All other contents of the said Notification and its Annexure shall remain same.
