
CORRIGENDUM

In partial modification of this Department's earlier No.12-W/2017-18 dated 08.08.2017 communicated vide No.2132(3)-IE/IE-100/2013 dated 08.08.2017 with annexes the Governor is hereby pleased, in the interest of public services, to make the following amendments, as stated below :-

'Official files, papers, documents and registers etc. of Resources Circle will be taken over and preserved by the Superintending Engineer (Design, Monitoring & Quality Control) attached to Chief Engineer (TBP)' shall be read as 'Official files, papers, documents and registers etc. of Resources Circle will be taken over and preserved by the Executive Engineer, Teesta Design Division, who will be under the control of Superintending Engineer (Design, Monitoring & Quality Control) attached to Chief Engineer (TBP)' The said Superintending Engineer (Design, Monitoring & Quality Control) will use the personnel of the office of the Chief Engineer (Teesta Barrage Project) including the Executive Engineer & Technical Assistant attached to the Chief Engineer (TBP) to perform various official functions. Note:1 of Annex-8 (Sheet-16/23).

All other contents of the said Notification and its Annexure and its subsequent corrigendum issued vide Order No.1548/1(2)-IE dated 21.06.2018 shall remain same.




