Agenda: Short listing of new State Plan Projects for inclusion under Core State Plan during the current financial year of 2016-17.

Secretary took the chair. Financial Advisor, Chief Engineer (South), Chief Engineer (North) and other officers remained present.

Few important projects were re-prioritised in the Departmental Review Meeting held on 18.11.2016 and it was decided that those projects are needed to be commenced in the current financial year itself and to be included under Core State Plan. Accordingly, a total of 8 nos. those re-prioritised schemes (sl. 1 to 8 of the Annexure) having an aggregated cost of ₹ 18.59 crore were placed before the Departmental Screening Committee (DSC) for obtaining formal approval towards inclusion under Core State Plan during the current financial year of 2016-17.

NABARD, Kolkata has returned 16 nos. of DPRs having aggregated cost of ₹ 33.00 crore (approx) originally submitted for inclusion under RIDF-XXII, later identified as ineligible due to their individual cost components of de-siltation items exceeding 15% of the project cost. Out of said 16 projects, 4 nos. schemes under sl. 1 to 4 of the Annexure are decided in the Departmental Review Meeting to be included under Core State Plan during this year.

Remaining 4 nos. schemes under sl. 5 to 8 of the Annexure are also approved for inclusion under Core State Plan during this year as decided in the said Departmental Review Meeting.

Scheme under sl. 9 relating to 'Anti erosion work at Debipur' was approved earlier in the DSC meeting held on 27.09.2016 at an estimated cost of ₹ 2.45 crore. Later, it was reported by CE (North) vide his No. 297-CI(N) dated 20.10.2016 that due to occurrence of heavy damages during draw down of flood discharge, a revised DPR is required to be framed at later stage. Now, CE (North) placed the revised DPR of ₹ 4.20 crore, framed in accordance with the changed site conditions and the same has been cleared by DSC.

It was stated by CE (South) in the meeting that savings of ₹ 4.00 crore was located out of overall budgetary allocation of CE (South) under Core State Plan and the same was communicated by him vide No. 01997-CI dated 07.12.2016. 2 nos. of schemes under sl. no. 10 & 11 of the Annexure having aggregated cost of ₹ 2.11 crore are cleared by the DSC for inclusion under Core State Plan out of the declared savings of ₹ 4.00 crore.

After a threadbare discussion, a total of 11 nos. of schemes at an aggregated estimated cost of ₹ 24.89 crore are cleared by the DSC for inclusion under Core State Plan during the current financial year of 2016-17.

The meeting ended with vote of thanks.
