The undersigned is directed to say that a 'Directorate Level Schedule of Rates Revision Committee' was set up vide this Department Order No. 13-(W)/2016-17 dated 30.05.2016 and communicated through Memo No. 36-IB on even date.

Consequent to above, the aforesaid committee has submitted to this Department its recommendations along with the draft of "Unified Schedule of Rates" (USoR) applicable throughout West Bengal in all districts as well as District Dumka under Mayurakshi Canal Circle vide Memo No. 01646-CI dated 28.09.2016 of the Chairman of the 'Schedule of Rates Revision Committee' i.e Chief Engineer (South), Irrigation & Waterways Directorate.

A high level Departmental meeting was held on 6<sup>th</sup> February, 2017 in the office chamber of Hon'ble Minister-in-Charge attended by Chief Engineers and other officers wherein it has been decided to bring into effect the Unified Schedule of Rates from 01.03.2017.

In the above context, as directed, the aforesaid draft Unified Schedule of Rates has been e-mailed to all Superintending Engineers and Chief Engineers in the Irrigation & Waterways Directorate. The same may be scrutinized within a maximum of 12 days and any discrepancy or error may be pointed out and send back to this Department in the same e-mail ID [deputysecretarygowb@gmail.com](mailto:deputysecretarygowb@gmail.com) latest by 19<sup>th</sup> February 2017.

The Department would be conveying to the Directorate Level Committee its approval immediately thereafter that so that the same may be published and brought into effect from 1<sup>st</sup> March 2017.
