ORDER

In continuation of this Department Order No. 2691-IE dated 31.08.2015, by which a direction was issued regarding presence of Chief Engineers of irrigation & Waterways directorate at their respective headquarters, the Governor in the interest of public service reiterates that presence of Chief Engineers of Irrigation & waterways Directorate at their respective headquarters is essentially required for the purpose of close monitoring and supervision of various activities of subordinate officers i.e. regular maintaining of schematic works, supervision of execution of works at sites, utilization of funds, sanction of plan & estimates and similar other activities for efficient functioning of the Department.

2. Accordingly, all the Chief Engineers whose offices are at Siliguri (C.E., TBP), Jalpaiguri (C.E., NE), Paschim Medinipur (C.E., SW), Burdwan (C.E., West) and Malda (C.E., North) are directed to stay at their respective headquarters on regular basis. They may attend the Jalasampad Bhavan only on the first and third Thursday & Friday of the month as specified in this Department's Order No. 2691-IE dated 31.08.2015. All official works like sanction of estimates, acceptance of tenders, sanction of health schemes and other establishment matters are to be performed at their respective offices. Other than these four days of the month stated above, they may not leave the headquarters and come to the head office at Jalasampad Bhavan, unless they are specifically called by the Minister-in-charge, Principal Secretary or Secretary of this Department to attend specific meeting or for urgent matters as may be required.
3. SEs, EEs & AEs under their respective jurisdiction may be accordingly intimated of all these arrangements.
4. It is also hereby directed that all the technical meetings, committee meetings, sanction of schemes/ projects etc. requiring the presence of Chief Engineers concerned should be organized only on the days of their availability at the Jalasampad bhavan as mentioned in Para-2 above.
5. The issue of deployment of different categories of employees is being looked into and will be communicated in a separate order.
6. This order will take immediate effect.
