2. The *SPMU – WBMIFMP, Kolkata* now invites online Bids from eligible Bidders for the construction of works detailed below in the Table-1. Bidders are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification Criteria), to qualify for the award of the contract. In addition, please refer to paragraphs 3.14 and 3.15 of the “Procurement Regulations” setting forth the World Bank’s policy on conflict of interest.

3. Bidding will be conducted through National Competitive procurement using Request for Bids (RFB) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers [July 2016, Revised November 2017 and August 2018] (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations.
4. Eligible Bidders from India are free to participate. No registration is required for participating.
5. The bidding document is available online on <https://wbtenders.gov.in>. from 31/01/2019 to 28/02/2019 free of cost as indicated in the table-2, Bidders will be required to register on the website, which is free of cost. The bidders would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.
6. For submission of the bid, the bidder is required to have Digital Signature Certificate (DSC) from one of the Certifying Authorities authorised by Government of India for issuing DSC. Aspiring bidders who have not obtained the user ID and password for participating in e-procurement in this Project, may obtain the same from the website: <https://www.nic.in>.
7. Bids must be submitted online on website: <https://wbtenders.gov.in> on or before **15.00 Hours (IST) on 28/02/2019** and technical part of the bid **will be opened online on the same day at 15:30 hours (IST)** at the address given below in the presence of the bidders designated representatives who wish to attend.. The “Financial Part” shall remain unopened in the e-procurement system until the second public Bid opening for the financial part. Any bid or modifications to bid received outside e-procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. The electronic bidding system would not allow any late submission of bids.
8. All Bids must be accompanied by a “Bid Security” amounting to **INR 3.53 Crores. [Indian Rupees Three Crores and Fifty Three lacs only]**. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. Procedure for submission of bid security is described in Para 9.
9. The bidders are required to submit (a) original bid security in approved form; and (b) original affidavit regarding correctness of information furnished with bid document with **Chief Engineer and Project Director, SPMU, WBMIFMP, 9th Floor, Jalasampad Bhavan, Western Block, Bidhannagar, Salt Lake City, Kolkata - 700-091, West Bengal** before the bid submission deadline, either by registered post/speed post/courier or by hand, failing which the bids will be declared non-responsive and will not be opened.
10. Bidders are advised to download the bidding document prior to the pre-bid meeting

in order for bidders to have a good understanding of the scope of work under this contract for discussion and clarification at the pre-bid meeting.

11. Other details can be seen in the bidding document. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to this bid.
