Sub: Administrative Approval and concurrent release of fund in connection with the project 'Drawal of a new 11 KV dedicated feeder for Kurebhanga Pump House' bearing scheme ID No. IW/CSP-23/2016-17 out of Core State Plan Budget Provision of this Department subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2016-17 to be implemented by West Bengal State Electricity Distribution Company Ltd (WBSEDCL).

The undersigned is directed to accord Administrative Approval for the project 'Drawal of a new 11 KV dedicated feeder for Kurebhanga Pump House' to be implemented by WBSEDCL on deposit term at an estimated cost of ₹169.00 lakh (Rupees One six nine point zero zero lakh) only out of Core State Plan Budget Provision of Irrigation & Waterways Department, subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year 2016-17.

The aforesaid work is scheduled to be implemented through Divisional Manager, Canning Division, WBSEDCL as **deposit work** as per his Memo No. DN/CNG/T-1/543 dated 22.08.2016.

Expenditure relating to the said project would be debitable to Demand No. 32 as contained in BP No. 20 under Core State Plan budget of this Department.

Further to above, entire cost of ₹ 169.00 lakh is concurrently released through on-line IFMS vide this Department's No. 324-IFS(W) dated 29.09.2016 in favour of the Executive Engineer, Metropolitan Electrical Division, I&W Dte for making payment to the WBSEDCL for the said purpose.
