Sub: Administrative Approval of scheme of "Improvement of Check Dam/Pickup weir cum bridge including canal and storage area of Niada check dam within Block & P.S. Onda, District-Bankura" under Bankura Irrigation Division out of 'Rashtriya Krishi Vikas Yojana' (RKVY) under State Plan (Voted) Budget of Irrigation & Waterways Department, subordinate to Demand No. 32 as contained in B.P No. 20 during 2016-17.

The undersigned is directed to say that State Level Sanctioning Committee (SLSC) on RKVY approved an outlay for a sum of ₹9.30 Crore under RKVY (Normal) during 2016-17 in favour of this Department on 08.06.2016 communicated vide No. 612-Nab./9M-27/2016 dated 13.06.2016 of Joint Secretary, Agriculture Department, Govt. of West Bengal which includes one new scheme of construction of check dam at Niada in the District of Bankura, which was included in the State Irrigation Plan (SIP) of 2016 and District Irrigation Plan (DIP) of Bankura District of 2016 under PMKSY at an aggregated cost of ₹5.97 Crore.

Annual outlay for I&WD under RKVY(Normal) during 2016-17 has been approved at ₹9.30 Crore, out of which ₹2.20 Crore has been earmarked for taking up new scheme during 2016-17. Spillover amount of ₹3.77 Crore has been phased in the next financial year. 1st installment of Central Share of ₹117.16 Crore has been released by Ministry of Agriculture, Govt. of India under RKVY during 2016-17 in August'16, out of which ₹1.87 Crore is allocated to this Department.

Now, the undersigned is directed to convey the sanction of the Governor towards Administrative Approval for the scheme of "Improvement of Check Dam/Pickup weir cum bridge including canal and storage area of Niada check dam within Block & P.S. Onda, District- Bankura", having scheme ID:RKVY-02/16-17 under Bankura Irrigation Division, at an approved cost of ₹596.44 Lakh under "Rashtriya Krishi Vikas Yojana" (RKVY) under State Plan (Voted) Budget of this Department subordinate to Demand No. 32 as contained in B.P No. 20 during 2016-17.
