Sub: **Administrative Approval for the project “Filling & Compaction of abandoned course of River Mora Torsa, since been diverted at Cooch Behar airport premises along with additional protection work for the earlier phase-I in connection with proposed extension of existing runway by Airport Authority of India in PS- Kotwali, Block- Cooch Behar-II Dist Cooch Behar” under Cooch Behar Irrigation Division bearing Scheme ID: IW/CSP-25/2016-17 out of Core State Plan Budget Provision of this Department, subordinate to Demand No. 32, contained in B.P No. 20 during the current financial year of 2016-17.**

The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval for the project '**Filling & Compaction of abandoned course of River Mora Torsa, since been diverted at Cooch Behar airport premises along with additional protection work for the earlier phase-I in connection with proposed extension of existing runway by Airport Authority of India in PS- Kotwali, Block- Cooch Behar-II in Cooch Behar District**' at an estimated cost of **Rs. 551.82 lakhs (Rupees Five five one point eight two lakh) only** out of Core State Plan Budget Provision of Irrigation & Waterways Department, subordinate to **Demand No. 32** as contained in B.P No. 20 during the current financial year of 2016-17 provided

1. That all Tender formalities as per Provisions of Rule 47 of WBFR as amended vide FD Notification No. 5400-F(Y) Dated 25-06-2012 and other related orders in this respect will be followed for selection of the contractors/suppliers.
2. That the project does not overlap with any central sector scheme or state sector scheme undertaken by this and/or other Departments of the State Government.
3. That the competent authority shall ensure that the executing authority has the authority to take up the work on the land in question like NOC from the respective Local Bodies etc. [Ref - FD Notification No. 10184-F(A-II) dated 13-12-2012].
