Sub: **Administrative Approval for 20 (twenty) schemes bearing scheme ID Nos. IW/CSP-117/2016-17 to IW/CSP-136/2016-17 out of Core State Plan Budget Provision of this Department, subordinate to Demand No.32 during the current financial year of 2016-17.**

The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval for 20 (twenty) schemes, having an aggregate estimated cost of **₹ 2612.87 lakh (Rupees Two six one two point eight seven lakh) only** under Core State Plan Budget Provision of Irrigation & Waterways Department, subordinate to **Demand No.32**, as shown in the Annexure to this Order during the current financial year of 2016-17 provided,

- That all the Tender formalities as per Provisions of Rule 47 of WBFR as amended vide FD Notification No. 5400-F(Y) dated 25.06.2012 and other related orders in this respect will be followed for selection of the contractors/suppliers.
- That the projects do not overlap with any central sector scheme or state sector scheme undertaken by this/other Department of the State Government.
- That the tender issuing authority/tender accepting authority shall ensure the right to take up the work on the land in question like NoC from the respective Local Bodies (Ref. FD Notification No. 10184-F(A-II) dated 13.12.2012).
