2. That the project does not overlap with any central sector scheme or state sector scheme undertaken by this and/or other Departments of the State Government.
3. That the competent authority shall ensure that the executing authority has the authority to take up the work on the land in question like NOC from the respective Local Bodies etc. [Ref - FD Notification No. 10184-F(A-II) dated 13-12-2012].
