IW/CSP-138/2016-17, IW/CSP-140/2016-17, IW/CSP-141/2016-17, IW/CSP-145/2016-17, IW/CSP-147/2016-17, IW/CSP-148/2016-17, IW/CSP-151/2016-17, IW/CSP-154/2016-17, IW/CSP-155/2016-17, IW/CSP-157/2016-17, IW/CSP-158/2016-17 & IW/CSP-159/2016-17 out of Core State Plan Budget Provision of this Department, subordinate to Demand No.32 during the current financial year of 2016-17.

The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval for 12 (twelve) schemes, having an aggregate estimated cost of ₹ 1265.19 lakh (Rupees One two six five point one nine lakh) only under Core State Plan Budget Provision of Irrigation & Waterways Department, subordinate to Demand No.32, as shown in the Annexure to this Order during the current financial year of 2016-17 provided,

- a) That all the Tender formalities as per Provisions of Rule 47 of WBFR as amended vide FD Notification No. 5400-F(Y) dated 25.06.2012 and other related orders in this respect will be followed for selection of the contractors/suppliers.
- b) That the projects do not overlap with any central sector scheme or state sector scheme undertaken by this/other Department of the State Government.
- c) That the tender issuing authority/tender accepting authority shall ensure the right to take up the work on the land in question like NoC from the respective Local Bodies (Ref. FD Notification No. 10184-F(A-II) dated 13.12.2012).
