Sub: Administrative Approval for 11 (eleven) schemes bearing scheme ID Nos. IW/CSP-242/2017-18 to IW/CSP-252/2017-18 out of Core State Plan Budget Provision of this Department, subordinate to Demand No. 32 during the current financial year of 2017-18.

The undersigned is directed to say that the Governor has been pleased to accord Administrative Approval for 11 (eleven) schemes, at an aggregate estimated cost of ₹ 3178.51 lakh (Rupees Three one seven eight point five one lakh) only under Core State Plan Budget of Irrigation & Waterways Department, subordinate to Demand No. 32, as shown in the Annexure to this Order during the current financial year of 2017-18 provided,

- a) That all the Tender formalities as per Provisions of Rule 47 of WBFR as amended vide FD Notification No. 5400-F(Y) dated 25.06.2012 and other related orders in this respect is to be followed for selection of the contractors/suppliers.
- b) That the projects do not overlap with any central sector scheme or state sector scheme undertaken by this/other Department of the State Government.
- c) That the tender issuing authority/tender accepting authority shall ensure the right to take up the work on the land in question like NoC from the respective Local Bodies (Ref. FD Notification No. 10184-F(A-II) dated 13.12.2012).
