**Sub: Revised Administrative Approval for the project “Dredging in river Muriganga in PSs Kakdwip & Sagar, District South 24-Parganas”.**

Ref: Memo No.350-IB dated 27.08.2018

The undersigned is directed to say that Administrative Approval of the above stated project was accorded vide this Department Memo No.350-IB dated 27.08.2018 with the concurrence of Finance Department vide their Group-F U.O No. Group-F/2018-19/0067 dated 17.08.2018 at an estimated cost of **₹120.30 Crore**, out of State Development Schemes Budget of I&WD during the Financial Year of 2018-19.


In the original proposal, GST was considered @5% on dredging items during preparation of cost estimate, but the actual rate of GST should have been @18% (9% CGST+ 9% SGST). Therefore, the proposal for revised administrative approval at a modified cost of **₹133.18 Crore** based on the correct rate of GST was prepared and submitted to the Finance Department for concurrence and got approved.

Now, the undersigned is directed to accord revised **Administrative Approval** of the project **“Dredging in river Muriganga in PSs Kakdwip & Sagar, District South 24-Parganas”** at a revised estimated cost of **₹133.18 Crore (Rupees One Hundred Thirty Three Crore Eighteen Lakh)** only, out of State Development Schemes Budget of I&WD during 2018-19.

All other contents of the original order will remain same.

This order issues with the concurrence of the **Finance Department, Group-F**, vide their U.O No. **Group-F/2018-19/0127 dated 12.11.2018**.
