Sub: Revised Administrative Approval for the project, "Raising, Strengthening & Improvement of Sundarban embankment by providing concrete block pitching for a length of 460M from ch. 14.50Km. to 14.83 Km. and from ch. 15.07 Km. to 15.20 Km. at Mouza Lakshmipur Abad in Block Namkhana, P.S. Frazerganj Coastal, Dist. South 24 Parganas" bearing Scheme ID No. IW/CSP-539/2018-19, out of State Development Schemes Budget Provision of this Department, subordinate to Demand No. 32, contained in B.P No. 20 during 2019-20.

The undersigned is directed to say that administrative approval of the original project was accorded vide this Departments No. 540(6)-IB dated 28.11.2018 with the concurrence of Financial Advisor, I & W Department vide his U.O No. 416 dated 26.11.2018 at an estimated cost of ₹592.98 lakh out of State Development Schemes budget of this Department in the Financial Year 2018-19.

Tender for the work was invited in which, out of the 04 nos. of technically qualified bidders the agency named **SUJOY KRISHNA JANA** with his offered rate of **8.88 % above the BoQ** emerged as the L1 bidder. The said L1 bid was accepted by the concerned Tender Inviting Authority in terms of I&W Department Memo No. 39-W/2016-17 dated 10.03.2017. As the revised estimated cost including 3% contingency over the tendered amount stands ₹644.12 Lakh which is more than the administratively approved cost, the instant case was referred to this Department for obtaining revised approval.

The undersigned is now directed to convey the Revised Administrative Approval of the project **"Raising, Strengthening & Improvement of Sundarban embankment by providing concrete block pitching for a length of 460M from ch. 14.50Km. To 14.83 Km. and from ch. 15.07 Km. to 15.20 Km. at Mouza Lakshmipur Abad in Block Namkhana, P.S. Frazerganj Coastal, Dist. South 24 Parganas"** at a revised estimated cost of ₹644.12 lakh (Rupees Six Hundred Forty Four Lakh Twelve Thousand) only inclusive of 3% contingency charges under State Development Schemes Budget of this Department, Subordinate to Demand No. 32 as contained in B.P No. 20 during the current financial year of 2019-20 subject to observance of all rules and regulations as applicable.
