No.-16 (Ch.0.00 to Ch.37.00 & Ch.90.00 to Ch.183.30), Dy.-17 (Ch.50.00 to Ch.87.00) for a length of 24.13 KM” sanctioned by NABARD in favour of Irrigation & Waterways Department under RIDF-XXV out of State Development Schemes (Voted) Budget subordinate to Demand No. 32 during the current financial year of 2019-20.*

The undersigned is directed to say that the Governor is pleased to accord Administrative Approval to the scheme “Improvement of Simlapal Branch Canal (S.B.C) by re-sectioning & C.C lining from Ch.180.00 to Ch. 370.00, Ch.405.00 to Ch. 427.00 & Ch. 610.00 to Ch.640.00 for a length of 7.2 KM along with its Distributaries viz. Dy.-1 (from Ch.120.00 to Ch.183.00), Dy.-5 (from Ch.12.00 to Ch.130.00), Dy.-6 (from Ch.8.00 to Ch.150.00), Dy. -8 (from Ch.0.00 to Ch.89.00), Dy.-11 (Ch.0 to Ch. 93.00), Dy.-14 (from Ch.0.00 to Ch.75.70) Dy.-14A (Ch.0 to Ch.116.00) and Dy. No.-16 (Ch.0.00 to Ch.37.00 &

Ch.90.00 to Ch.183.30), Dy.-17 (Ch.50.00 to Ch.87.00) for a length of 24.13 KM” sanctioned by NABARD at an estimated cost of **Rs. 2377.69 lakh** (*Rupees Two Thousand Three Hundred and Seventy Seven point Six Nine Lakh*) only, under State Development Schemes Voted Budget of Irrigation & Waterways Department, subordinate to **Demand No. 32** contained in B.P No. 20, chargeable to the head of account ‘4700-80-800-002-53-V’.
