The undersigned is directed to say that the Governor is pleased to accord Administrative Approval in respect of 24 no. of new projects sanctioned by NABARD under RIDF-XXVI at an aggregate estimated cost of **Rs. 405.80 crore** (*Rupees Four Hundred Five crore and Eighty Lakh*) only as detailed in the 'Annexure' to this order out of State Development Schemes Voted Budget of Irrigation & Waterways Department, subordinate to Demand No. 32, contained in B.P No. 18.
