#### Additional Conditions

##### Conditions Description

- 1 The tender was earlier invited after adopting Standard Bid Document (SBD), prepared by the the Chief Engineer (South-West) based on the Standard Bid Document (SBD) of Ministry of Surface Transport, Gol for procurement of civil works, after getting consent from the I & W Department vide Memo No- 767-IB-IW/O/IB-Misc-66/2017-18(Pt-I).
- 2 Later, the post-facto approval of the Finance Department was conveyed to the Chief Engineer (South-West) vide Memo No 71-IB-IW/14011(21)/1/2020-Section (IW) dated-17.05.2022, towards adoption of the Standard Bid Document of Ministry of Surface Transport, Gol for the instant work as well as permission for signing the contract in the Agreement Form attached to the said SBD instead of WB Form 2911, subject to the following amendment :-  
 (a) Provision towards correlating prior establishment of contractor's site office and Quality Control Laboratories with the release of mobilization advance,  
 (b) Provision towards checking of quality at departmental quality control laboratories in addition to that at contractor's Q/C Laboratories.
- 3 The Contract Agreement has to be signed in the Agreement Form attached to the said SBD approved by the FD after incorporating the two nos amendments as mentioned above at sl no-2.
- 4 The day to day supervision of works, taking measurement of executed works in Measurement Books (MBs) and Level Books (LBs), suggesting to the Engineer any addition & alteration in drawings, suggesting to the Engineers any excess of items, ensuring day to day quality control etc. of the instant work will be carried by the respective Division involving the Project Management Consultancy i.e. RITES Ltd as per the terms and conditions of the signed agreement between RITES Ltd. and the SE/Western Circle-II.
- 5 The Chief Engineer (South West), I&W Dte. will be the over all in-charge of the Project and he will also sign the Contract Agreement on behalf of the Government.
- 6 10 nos of Executive Engineers under the administrative control of the Chief Engineer (South-West) (8 nos) and Chief Engineer (West) (2 nos) will act as the EIC for the bridge constructions within their respective jurisdictions, as stated in the Contract Data of the Bid Document. They will demarcate their site/land for taking up execution, after joint site visit. They will also forward their bills of work for respective jurisdictions to the DDO for making payment to the Contractor centrally. The Executive Engineer, West Midnapore Division, I&W Dte. will act as DDO of the work.
- 7 The completion period of the construction work will be 30 months from the date of issuance of the Work Order.
- 8 The Finance Department has agreed to concur with proposal of I & W Department regarding acceptance of single bid received in the 3rd call of the e-tender for the work "Construction of 122 nos. RCC bridges over drainage channels and irrigation canals as part of Infrastructure GAP project in the districts of Bankura, Paschim Bardhanan, Jhargram, Purba & Paschim Medinipur in West Bengal" @ 13.97% above the amount put to tender [Tendered Amount Rs. 275.40 Crore ] vide UO NO : Group T/2021-2022/0814 dated- 17.11.2021, provided all other Rules, Regulations and Provisions have been properly observed by the TIA. The Chief Engineer (South-West) will formally accept the tender based on the concurrence of the Finance Department.
