

Madam/ Sir,

I am directed to refer to the State Government of West Bengal (SGoG) letter No. 1064-FB dated 27.11.2024 received through email dated 04.12.2024 submitting therewith a proposal consisting of 5 capital projects for seeking special assistance (loan) amounting to Rs. 371.64 crore under Part-VIIA of the 'Scheme for Special Assistance to States for Capital Investment 2024-25' and Department of Land Resources (DoLR) OM No. 18011/01/2024-LRD(e-3014184) dated 12.11.2024 regarding recommendation for State of West Bengal in respect of Milestones-2&4 under Part VIIA of the 'Scheme for Special Assistance to States for Capital Investment 2024-25'.

2. In this context, it is to state that the total amount recommended under Part VIIA of the Scheme to the State Government of West Bengal is Rs. 65.51 crore. Accordingly, as per the recommendation from DoLR, the competent authority has approved the capital expenditure amounting to Rs. 65.51 crore on the capital projects posed by the State Government of West Bengal under Part-VIIA of the 'Scheme for Special Assistance to States for Capital Investment 2024-25' as per details given below:
