Sub: Division-specific allocation under SDS (M) Budget towards 'AMC of Drainage Channels for 2025-26' over and above 'Pre-monsoon Allocation of 2025-26' in adherence with the SOP vide Memorandum No. 07-W/2023-24 dated 12/06/2023.

Ref: Proposals as received through OPMS duly approved by the Chief Engineers concerned.

The undersigned is directed to reiterate that the Drainage Channels are classified into two categories, viz 1) **Type-A** (for Remaining Urbanized Areas) & 2) **Type-B** (for heavily Urbanized areas out of urbanized area).

- 2. It is further to be taken note of that the frequency of cleaning considered in AMC for Type-A Drainage Channels is specified as 'twice in a week for monsoon and once in a week for non-monsoon seasons', whereas that for Type-B Drainage Channels is 'thrice in a week for monsoon and twice in a week for non-monsoon seasons'.
- 3. Now, considering the importance of cleaning of the canals mainly in urban areas through AMC with the view of curbing vector borne diseases and ensuring smooth canal flow, the undersigned is directed to say that the Division-speficic allocation as enumerated in the 'Annexure' with immediate tender permission is hereby accorded. However, the work orders are to be issued after tender process and issuance of AAFS.



- 4. It is further to say that if some savings in SDS(M) budget is located in the meanwhile, it would be endeavoured to issue AAFS at least for those canals for which existing AMC is closing at the end of March, 2025 or in the 1st or 2nd week of April, 2025. DPRs should be generated, forwarded & submitted through OPMS on 'Estimated Cost' basis within 16/03/2025.
- 5. The undersigned is further directed to specify that under no circumstances, the length of Type-B channels should be compromised.
- 6. This is issued with the approval of the Additional Chief Secretary of this Department.
