Sub: Extension of the benefits in terms of Finance Department's Memo. No. 9008-F(P) dated 16.09.2011 to the contractual workers (Tracer, Draughtsman and Surveyor) engaged at different offices under Irrigation & Waterways Directorate.

The undersigned is directed to say that approval for filling up of 5 (five) posts of Tracer, 10 (ten) posts of Draughtsman & 15 (fifteen) posts of Surveyor was accorded, initially for a period of six months under this Department's Memo No. 1598-IE-3M-11/2011 dated 12.07.2012, issued with the concurrence of the Finance Department, vide their U.O. No. 1576 Group P (Service) dated 25.06.2012. Accordingly, those posts were filled up on contractual basis. The tenure of engagement of those contractual workers were extended from time to time with the approval of the Finance Department. Of those contractual workers, 1 (one) No. of Tracer, 2 (two) No. of Draughtsmen & 9 (nine) No. of Surveyors, as mentioned in the annexed list, have been working for a long time without any interruption and have been found to be eligible for having the benefits as delineated in Memorandum No. 9008-F(P) dated 16.09.2011 of the Finance Department. Adequate number of vacancies in those posts are also available in this Department.

In view of the above, the undersigned is directed to say that it has been decided by the Government that all the benefits like tenure of engagement, yearly enhancement of remuneration, leave facility etc., as delineated in the Finance Department's order No. 9008-F(P) dated 16.09.2011 and subsequent Memorandums No. 1107-F(P) dated 25.02.2016 & No. 1033-F(P2) dated 08.02.2019 shall be extended to those contractual workers and henceforth, their service conditions shall be guided by the aforementioned orders.

This order is issued with the concurrence of the Finance Department, vide their U.O. No. Group P2/2020-2021/0723 dated 29.01.2021 and with the approval of the Secretary of this Department.

This order takes effect from the date of issue.


