e is therefore, once again, instructed to obtain the willingness/unwillingness in writing, to accept the promotion to the post of ACRO, from the above mentioned Head Clerk under his respective control and submit the same to the undersigned immediately within 15 (fifteen) days of issuance of this letter, failing which the incumbents concerned will be treated as unwilling to accept the said promotion to the post of ACRO.

If any of them, whose names appear in the list above, are found to be willing to accept the said promotion, his/their ACRs for the period from 2015-16 to 2020-21 must also be submitted to the undersigned alongwith his/their willingness in writing, to accept the said promotion




