Agenda: Proposal for recommendation of 14 (fourteen) new schemes (costing below Rs 1.50 crore) for inclusion under Core State Development Schemes(Voted)budget of Irrigation & Waterways Department during the current FY of 2021-22.

Secretary took the chair.

The following were discussed:

1. DPR of 11 no. of schemes included in the list of 107 schemes selected in the Departmental Review Meeting taken by Hon`ble MIC on 13.07.2021 were initially placed in the meeting. Three more schemes were discussed during the meeting under East Midnapore Division, Berhampur Irrigation Division and Damodar Headworks Division, of I&W Dte.
2. Out of 14 schemes, 01 no. scheme ( under sl 1) technically recommended by the Directorate Level Technical Committee in their 6<sup>th</sup> Meeting held on 23.08.2021 , 01 scheme (under sl 13) has been technically recommended by the Directorate Level Technical Committee in their 16<sup>th</sup> Meeting held on 16.12.2021 .02 schemes ( under Sl 2, 3) technically recommended by the Directorate Level Technical Committee in their 19<sup>th</sup> Meeting held on 29.12.2021, 1 no. of scheme (Sl 12) technically recommended by the Directorate Level Technical Committee in their 20<sup>th</sup> Meeting held on 13.01.2022, 7 no. of schemes (Sl 4, 5, 6, 7, 8, 9, 13, ) technically recommended by the Directorate Level Technical Committee in their 21<sup>st</sup> Meeting held on 19.01.2022, , Now all the schemes have been recommended by the DSC.
3. For 01 scheme (under sl 10) of Kangsabati Canal Division–II, Khatra has been technically recommended by the Directorate Level Technical Committee in their 18<sup>th</sup> Meeting held on 24.12.2021, The scheme was initially placed in the DSC meeting held on 31.12.21, wherein it has been directed to re-submit the scheme with some modification by omitting jacketing items . Now the scheme has been re-submitted after necessary compliance of the DSC meeting held on 31.12.21 and has been recommended by the DSC.
4. For 01 scheme (under sl 11) related to re-construction of one RCC bridge of Kangsabati Canal Division-III, Bishnupur was initially placed in the DSC meeting held on 01.11.21 but not resolved. This scheme has been technically recommended by the Directorate Level Technical Committee in their 8<sup>th</sup> Meeting held on 10.09.2021 & same has been recommended by present DSC.

5. For 01 scheme (under sl 14) related to rehabilitation 26 no. sluice gates at Kalyani under Metropolitan Mechanical & Electrical Division was initially placed in the DSC meeting held on 18.08.21 [ sl 03] and recommended in said meeting . But Administrative Approval of this department has not been accorded. Meanwhile the scheme has been re-submitted by the concerned Chief Engineer with some modification and the same has been technically recommended by the Directorate Level Technical Committee in their 19<sup>th</sup> Meeting held on 29.12.2021. Considering the submission of the Chief Engineer(Mechanical & Electrical) and the concerned Superintending Engineer and recommendation of the DLTC , the scheme has been recommended by the DSC by superseding the contents of the sl 3 of the enclosure of the RoD of the DSC held on 18.08.2021 circulated vide no.171/IB dated 07.09.2021
6. Finally, 14 nos. schemes as per Annexure have been cleared by the DSC for inclusion under Core State Development Schemes budget of I&WD under Demand No. 32, B.P no 18 during the current FY 2021-22.
7. It has been directed to submit the soft copy (PDF version) of all the schemes as per enclosed list duly technically sanctioned after incorporation of the minor changes as suggested in the DSC meeting.






