It has been come to notice that for some time past, some employees of regional cadres of Regional Offices, on getting promotion to higher post have been found to express their reluctance to accept the promotion, - instances of such refusal is increasing day by day causing administrative inconvenience.

In the interest of administrative convenience and with a view to deal with such refusals of promotion it has been decided : -

1. The employees who is reluctant to accept the promotion must have to submit in writing within a week after receiving the promotion order that he is unwilling to accept the promotion.
2. The employees who will refuse the promotion will be considered for further promotion only after expiry of one calendar year from the date of issue of relevant promotion order without any prejudice.
3. The matter of refusal of promotion will have to be recorded in the Service Book of the concerned employee and after recording the same the Service Book must be sent to the undersigned for verification.
