It may be mentioned that **mandatory online submission of SAR** has been initiated from the Appraisal Year 2017-2018 onward in terms of F.D.'s Notification No. 5744-F(H) dt. 06.9.2018.

Therefore I am, further, directed to request you to submit compressive report regarding submission of APR and SAR of Shri Kuntal Roy for the aforesaid period with your opinion in the light of F.D.'s Notification No. 2861-F(Y) dated: 06.05.20218 and F.D.'s Notification No. 5744-F(H) dt. 06.9.2018, **within seven days from the date of receipt of this letter.**
