NOTIFICATION

In continuation to Notification No.3564-WT/3M-81/98 dated 24.11.2008 and Notification No.3200-WT/3M-81/98 dated 26.09.2011, the Governor has been pleased to make partial modifications as follows:

(I) Add the following in the SCHEDULE of Notification No.3564-WT/3M-81/98 dated 24.11.2008

Sl. No.	Type of Vehicle	Monthly Hiring Charges	Fuel	Remarks
6	Electric Vehicle	₹ 46,000/- For up to 100 KM run per day	N.A.	Extra payment of ₹ 8/- per KM to be paid for extra run beyond 100 KM.

(II) Clause (6) of the SCHEDULE of Notification No.3564-WT/3M-81/98 dated 24.11.2008 shall substitute as under:

6. A vehicle to be hired by the Government Departments / Offices shall require prior concurrence of Finance Department as usual. Express permission of the Finance Department shall also be required for hiring of vehicles of the categories other than Non-Air Conditioned Motor Cab and Maruti Omni.

Petrol driven vehicles may also be hired by the Government Departments without special permission of the Financial Department.

This is issued with the concurrence of Finance Department vide their U.O. No. Group T/2023-2024/0021 dated 17.04.2023 read with U.O. No. Group T/2023-2024/0510 dated 07.08.2023.

This shall take immediate effect.
