Sub.: Prayer of Sri Krishna Murmu, Upper Division Clerk of Mayurakshi Revenue
Division-II, I&W Dte., under RTI Act- 2005

With reference to the subject cited above, the following informations are being forwarded herewith.

1) Posting is given as per positions in the Gradation List of the Upper division Clerk. That is, who is senior will get better posting opportunity. The Serial No of the 3(Three) Upper Division Clerks as per Gradation List published Vide This Office Memo No. 3619 (110)-CIE/1S-16/19 Dated 17/07/2023, who have been promoted to the post of Head Clerk is as follows-

- i) Md. Jafar Imam Ansari- SI No. 58
- ii) Tarak Mondal- SI No. 195
- iii) Krishna Murmu (Applicant)- SI No. 201

As there were 2(Two) posts of Head Clerks lying vacant in Birbhum District, i.e. Mayurakshi Canal Circle and Mayurakshi Revenue Division No-I, hence the first 2(Two) employees were the first choice.

2) Among the 34 (Thirty-Four) employees promoted to the post of Head Clerks, 8(Eight) were the reserved category, i.e., 24%. Hence, **the question of discrimination is hereby ruthlessly turned down.**

3) **No favouritism, nepotism is encouraged from this end.** The only interest lies of the office of the undersigned is to confer promotion to the employees which is their legitimate claim. Hence, the specific treatment to one person at the expense of other does not hold good. He is hereby directed to clarify, with supportive documents to prove that the employees of the office of the undersigned have vested interest in this regard. And **why action will not be taken against him for defaming the employees.**

4) 2 (Two) posts of Head Clerks were lying vacant in Birbhum district. 3 (Three) employees were there who were considered for promotion. As this is exclusively the discretion of the appointing authority, hence he was transferred to Chief Engineer (North).

5) The allegation is totally baseless and imaginary. 2(Two) employees belonging to The Scheduled Tribe (ST) community were given promotion – as there was vacancy in South west Mechanical & Electrical Circle, 1(One) was given suitable posting.

6) As there were only 2(Two) vacancies in Birbhum district, 1(One) was transferred to Malda district.
