## **CIRCULAR**

The matter of illegal dredging or de-siltation in different rivers of the State of West Bengal, has always been a concern of the State Government.

The State Government has taken suitable measures from time to time to check such illegal dredging-de-siltation, in different parts of the State.

It is once again directed that all District Magistrates and other stakeholders shall take all possible steps to ensure no such illegal activities e.g.; unauthorized or illegal dredging/desiltation or unauthorized or illegal extraction and stockpiles of riverbed materials, take place in their respective jurisdiction. Any such illegal act/activities should be dealt with, in accordance with law.

Periodical monitoring, surprise inspections and strict vigil shall be continued without fail.
