

3. After clicking in RHE portal, a new page will appear and Applicants have to select "Choose this option if you have already submitted a physical(hard copy) application for flat".
4. Applicants will have to submit their Computer Serial No. or physical application number which is basically the Receiving No. mentioned on their hard copy of application.
5. Applicants are requested to submit their HRMS ID mandatorily while follow the above procedure.
6. In case of non submission or delayed submission of HRMS ID by concerned employee, his/her position in the waiting list may be changed and he/she may get the accommodation later on.


