The concerned Superintending Engineers & Executive Engineers also remained present.

Agenda: Proposal for recommendation of 17 (Seventeen) new schemes for posing under
“RIDF-XXVIII” for Irrigation & Waterways Department.

Secretary took the chair. At the onset of the meeting, he reiterated the importance to follow guidelines of RIDF scheme preparation issued by NABARD during 2013-14, which is shared

in the IWD Whatsapp group. He also advised to follow suggestions issued in the RoD of DSC held on 23.06.2022 for RIDF-XXVIII schemes. He requested the Superintending Engineer, Investigation & Planning Circle-I, I&W Dte to check all DPRs following the same before submission to NABARD through the Chief Engineer (South), I&W Dte. The scheme wise discussions and findings of the DSC are as follows:

1. 'Renovation, strengthening and re-sectioning of damaged canal bank and lining work of Distributary No. I of T.M.L.C. from chainage 0.000 Km to 21.225 Km including its Minors in P.S.-Bhaktinagar and Jalpaiguri, Block: Rajganj and Jalpaiguri Sadar, District: Jalpaiguri' at an estimated cost of ₹1961.65 Lakh (under Sl 1) has been placed in the present DSC meeting and advised for test checking by DLTC as earthwork amount seems to cross 15% limit of total estimated cost and to explore the replacement of geo filter with conventional granular filter below concrete lining.
2. 'Raising & Strengthening of Sundarban Embankment from Ch. 21.050 Km to Ch 21.950 Km (Total length: 900.00 m) by armourring with 25 cm thick brick block pitching along the right bank of river Gomor at Mouza: Rangabelia in Block: Gosaba, P.S.-Gosaba, District: South 24 Parganas' at an estimated cost of ₹665.57 Lakh (under Sl 2) has been placed in the present DSC meeting and recommended.
3. 'Raising & Strengthening of Sundarban Embankment for a total length of 1.26 Km along the left bank of river Dansa at Mouza: Tangramari (0.36 Km) Khanpukur (0.52 Km) & Chalkpatli (0.38 Km) in Block: Hasnabad, District: North 24 Parganas' at an estimated cost of ₹840.36 Lakh (under Sl 3) has been placed in the present DSC meeting and recommended.
4. 'Construction of protection work from Spur at Ch. 4240.00 m of Jalpaiguri Town Protective Embankment to Spur No. 01 of Segregating Embankment via Spur at Ch. 3710.00 m of Jalpaiguri Town Protective Embankment on the right bank of river Teesta within South Sukanta Nagar area under Kharia G.P., Block: Sadar, District: Jalpaiguri' at an estimated cost of ₹328.76 Lakh (under Sl 4) has been placed in the present DSC meeting and recommended.
5. 'Reconstruction and strengthening of embankment along the right bank of river Diana for a length of 2400.00 m from Tikanpur forest to Kherkata village in PS Banarahat, Block- Nagrakata, District: Jalpaiguri' at an estimated cost of ₹526.96 Lakh (under Sl 5), is not included in the original approved list of RIDF-XXVIII schemes. However, the scheme is


under consideration for posing under RIDF-XXVIII from savings of other schemes. The scheme has been placed in the present DSC meeting and recommended.

6. 'Protection work on the left bank of river Mahananda at Chiarujote area, Badlagachh area and at the right bank of river Mahananda at Majhua area for a length of 1385 m and at the left bank of river Singhijhora at Taribari area for a length of 1500 m in P.S.- Bhaktinagar, District: Jalpaiguri' at an estimated cost of ₹526.96 Lakh (under Sl 6) has been placed in the present DSC meeting and recommended.
7. 'Bank protection work at Baro Laukuthi area for a length of 1150m and along the left bank & Uttar Falimari area for a length of 400m along the right bank of river Sankosh within Block Tufanganj II, P.S. Boxirhat, District: Coochbehar' at an estimated cost of ₹580.81 Lakh (under Sl 7) is not included in the original approved list of RIDF-XXVIII schemes circulated by the Department. However, the scheme is under consideration for posing under RIDF-XXVIII from savings of other schemes. The scheme has been placed in the present DSC meeting and recommended.
8. 'Protection work along the left bank of river Rupnarayan at Benia and Antila for a length of 400.00 m in G.P.: D. Mondal Ghat- I & II, Block: Shyampur-II, P.S.: Shyampur, District: Howrah' at an estimated cost of ₹259.25 Lakh (under Sl 8) has been placed in the present DSC meeting and recommended.
9. 'Protection work along the left bank of river Rupnarayan for a length of 1200.00 m near Chitnan Flood Centre in Mouza: Chitnan, G.P.: G.B. Chitnan, P.S.: Joypur, Block Amta-II, District: Howrah' at an estimated cost of ₹451.90 Lakh (under Sl 9) has been placed in the present DSC meeting and recommended.
10. 'Protection to the right bank of river Ajoy near Sankhai Ghat for length of 1350.00 m at Mouza- Begunkola within Ketugram-II Block, P.S. Ketugram, District: Purba Bardhaman' at an estimated cost of ₹395.61 Lakh (under Sl 10) has been placed in the present DSC meeting and advised for **resubmission** of the scheme with suggestion to check observed scour level and calculated scour level and re-calculate scour filling quantity.
11. 'Reconstruction of Chandipur-I sluice and Ranichak sluice over left embankment of river Chandia at Mouza: Chandipur in Block & P.S Pingla and on Banskhana khal at Ranichak in Block & P.S Sabang respectively, District: Paschim Medinipur' at an estimated cost of ₹487.22 Lakh (under Sl 11) has been resubmitted and placed in the present DSC meeting and recommended.

12. 'Reconstruction of Dakshin Bengai sluice over Bengai khal at Mouza: Dakshin Bengai, Block: Medinipur Sadar, P.S.-Kotwali, District: Paschim Medinipur' at an estimated cost of ₹487.22 Lakh (under Sl 12) has been placed in the present DSC meeting and recommended.
13. 'Improvement of 4-I Main Canal of MMC system by re-sectioning and concrete lining from Jamna to Barjeeban (10.00 Km) including construction of guard wall, culvert, outlets in Block & P.S – Pingla & Sabang, District: Paschim Medinipur' at an estimated cost of ₹1382.00 Lakh (under Sl 13) has been placed in the present DSC meeting and recommended with suggestion to resubmit the scheme with the signed drawing of Central Design Office relating to RCC fall structure.
14. 'Protection of left bank of river Shilabati at Mouza- Krishnanagar, Kantapal & Bhattugram, G.P. Benachapra, Block: Garhbeta-I, P.S.-Garhbeta, and left embankment of river Shilabati at Mouza-Hiradharpur, G.P. Manoharpur-I, Block -Chandrakona-I, P.S.-Chandrakona, District: Paschim Medinipur, for a length of 2.00 Km' at an estimated cost of ₹550.56 Lakh (under Sl 14) has been placed in the present DSC meeting and recommended with suggestion (i) to properly show pond in the cross section drawings and (ii) to modify the scheme name as 'Protection of left bank of river Shilabati for a length of 1600m at Mouza- Krishnanagar, Kantapal & Bhattugram, G.P. Benachapra, Block: Garhbeta-I, P.S.- Garhbeta, and of left embankment of river Shilabati for a length of 400m at Mouza- Hiradharpur, G.P. Manoharpur-I, Block -Chandrakona-I, P.S.-Chandrakona, District: Paschim Medinipur'.
15. 'Protection and Strengthening of Titidanga - Jurankandi Embankment for a total length of 2350 M in 3 stretches in between Ch. 1.155 Km to Ch. 10.500 Km at Village: Dangapara, Chorkanta and Ratanpur under P.S.- Nabagram, District: Murshidabad' at an estimated cost of ₹482.75 Lakh (under Sl 15) has been placed in the present DSC meeting and recommended.
16. 'Improvement of canal system of Kopai South Main Canal of Mayurakshi Reservoir Project from Ch. 895.00 to Ch. 1127.00 & from Ch. 1229.00 to Ch. 1779.00 (Total length 23.46 Km) and Distributory No.4 (Ch 0 to Ch.276), Minor-I (Km.) within Block- Bolpur-Sriniketan and Nanoor in the District of Birbhum' at an estimated cost of ₹4603.67 Lakh (under Sl 16) has been placed in the present DSC meeting and recommended.
17. 'Improvement of Mayurakshi Dwarka Branch Canal from Ch. 780.00 to Ch. 1300.00 (working length of 15.85 Km) and distribution system comprising Distributories (Dy-8A

(Ch.0.00 to Ch.78.25), Dy-9 (Ch.152.59 to Ch.247.28), Dy-10 (Ch.137.80 to Ch.252.07), Dy-12 (Ch.0.00 to Ch.110.60) & Dy-13 (Ch.137.79 to Ch.275.03) by re-sectioning with pre-cast CC lining, rehabilitation of structure in the Block of Mayureswar-I & Mayureswar-II, District of Birbhum and Block of Burwan, District of Murshidabad' at an estimated cost of ₹2757.87 Lakh (under Sl 17) has been placed in the present DSC meeting and recommended.

It has been directed to submit the hard copies (2 sets) and soft copy (PDF version) of DPR of all 15 recommended schemes (Sl- 2, 3, 4, 5, 6, 7, 8, 9, 11, 12, 13, 14, 15, 16, and 17) as stated above, after incorporation of the minor changes as suggested in the DSC meeting, to the Superintending Engineer, Investigation & Planning Circle-I, I&W Dte for checking and onward submission to NABARD through the Chief Engineer(South), I&W Dte. The modified D.P.R of the schemes, asked for resubmission (Sl.10) and D.P.R of scheme (Sl.1) recommended for test checking at DLTC, are to be given to the Superintending Engineer, Investigation & Planning Circle-I, I&W Dte, who will examine and place those schemes in the next meeting of the DSC, if found compliant to the observations of the DSC.


