ORDER

In inviting a reference to e-NIT No. WBIW/SE/GCDC/NIT-05(e)/2017-18 (Sl. 02) of Superintending Engineer, Greater Calcutta Drainage Circle, I & W. Directorate, Jalasampad Bhawan, Salt Lake City, Kolkata-700 091, it is observed that "Cognition Projects Pvt. Ltd." having registered office at Room No. 6B, 2nd Floor, 158, Lenin Sarani, Kolkata-700 013 and its correspondence office at D/1, Ramkrishna Upanivesh, Sulekha, Jadavpur, Kolkata-700 092, participated in that tender. After opening of technical bid, during verification of the original documents, it was detected that the documents relating to the work credentials submitted by the said Bidder were false and fabricated.

Now, in view of above and as per recommendations of the **Technical Evaluation Committee** (**TEC**) and the **Departmental Tender Committee** (**DTC**) in their meeting, in exercise of the powers conferred on the undersigned under **Clause-9** of "**General Terms & Conditions for e-tenders**" and in terms of **Clause-5.0** of **Annexure** to Memorandum No. 03-W/2017-18 dated 18.05.2017 of I & W. Department, the defaulting Bidder, i.e., "**Cognition Projects Pvt. Ltd.**" is, hereby debarred from participating in all tenders of I & W. Department for a period of **6 (six) months** with effect from the date of issue of this order. In addition, the **Earnest Money** of the Bidder stands forfeited by the Government.

The Superintending Engineer, Greater Calcutta Drainage Circle, I & W. Directorate, is instructed to take necessary action for forfeiting the **EMD** of the bidder with immediate effect.

This order shall be brought to the notice of all concerned for strict compliance.
