

ORDER

South 24 Parganas, Pin – 743347 participated in that tender process. During verification of the original documents, it was detected that the documents relating to the work credential submitted by the bidder was false and fabricated. Even the issuing authority of the said documents also confirmed that the same was false. Now, in view of the above and as per recommendation of Departmental Tender Committee (DTC) in the meeting held on 22.02.2018, in exercise of the powers conferred upon the undersigned under Clause-8 of e-NIT and in terms of clause 5.0 of Annexure to Memorandum No 03-W/2017 dated 18.05.2017 of I & W Deptt., "Babul Chandra Dey" is hereby debarred to participate in all tenders of I & W Department for a period of 6 (Six) months with effect from 23.02.2018 and earnest money of the bidder stands forfeited.

The Superintending Engineer, Eastern Circle is instructed to take necessary action to forfeit the earnest money deposited by the bidder with immediate effect.


This order shall brought to the notice of all concern for strict compliance.
