The "Abhishek Adhikari (Bid ID : 2170639)" Durlavgang (C.K Road), P.O- Sat Bankura, Dist:- Paschim Medinipur, PIN 721253 has violated norms & rules during competitive bidding and contract implementation by uploading of falsified and forged document relating to work credential against e-NIT No. WBIW/SE/KC-II/NIT-01e/2021-22. In accordance with I & W Deptt. No. 03-W/2017-18 dated 18/05/2017 and corrigendum Memo. No. 10-IB /IW/P/IB/Misc-03/2017-18 dated 06/04/2018 the TEC of the said tender, recommended for debarment from participating into any procurement for "Abhishek Adhikari (Bid ID : 2170639)". As per the above recommendation of the TEC the matter was placed before the Departmental Tender Committee for South Bengal, I&W Department which upheld the recommendation of the TEC.

Now in compliance with the I & W Deptt. No. 03-W/2017-18 dated 18/05/2017 and corrigendum Memo. No. 10-IB /IW/P/IB/Misc-03/2017-18 dated 06/04/2018 and as per recommendation of the Departmental Tender Committee for South Bengal, I&W Department the bidder "Abhishek Adhikari (Bid ID : 2170639)" Durlavgang (C.K Road), P.O- Sat Bankura, Dist:- Paschim Medinipur, PIN 721253 is debarred from entering into any procurement system for a period of six month from 07/07/2021 to 02/01/2022 and his Earnest Money against the e-NIT No.- WBIW/SE/KC-II/NIT-01e/2021-22 will be forfeited by the Competent Authority.




