Sub: WPA No. 412 of 2023 in the matter of M/s. Corporate Wave Builders Vs. The State of West Bengal & Ors.

The undersigned is directed to say that the Office Order dated 19.01.2023 issued by the Chief Engineer, North-East, Irrigation & Waterways Directorate, debarring the Agency named M/s. Corporate Wave Builders, having address at Ashoke Nagar, Post & Dist. Jalpaiguri, from participating in all tenders under Irrigation & Waterways Department for a period of 01 (one) year with effect from 20.01.2023, has been stayed by the Hon'ble Calcutta High Court, in the Circuit Bench at Jalpaiguri vide the interim order dated 28.02.2023, passed in the matter mentioned above, directing inter-alia that the respondent authorities are restrained from giving any effect and/or further effect to the impugned order debarring the petitioner from participating in the tender process of the Irrigation & Waterways Department.

The aforesaid interim order would remain valid till 30.06.2023 or until further order whichever is earlier, as directed by the Hon'ble High Court, Calcutta.
