



OFFICE ORDER

The L1 Bidder, “Pranab Jyoti Chatterjee”, 65/47, N.C. Ghosh Sarani, Seoraphuly, District- Hooghly, has violated norms and rules during competitive bidding and contract implementation by submitting the fake documents with respect to establish his credentials against e-NIT No. WBIW/EE-II/LDID/E-NIT-2/2022-23 (Tender ID: 2022_IWD_376313_1). In accordance with the I&W Department’s Memorandum No. 03-W/2017-2018 dated 18.05.2017 and Memo No. 10-IB/IW/P/IB/Misc-03/2017-2018 Dated 06.04.2018, the Technical Evaluation Committee of the said Tender recommended for debarment from participating in to any procurement for “Pranab Jyoti Chatterjee”. As per the recommendation of the TEC the matter was placed before the Departmental Tender Committee which upheld the recommendation with non-issuance of any completion certificate so the bidder cannot use it for securing further works.

Now in compliance with the I&W Department’s Memorandum No. 03-W/2017-2018 dated 18.05.2017 and Memo No. 10-IB/IW/P/IB/Misc-03/2017-2018 Dated 06.04.2018, Memo No. 48-IB/14011(33)/2/2021-SECTION(IW) [376266] Dated 31.01.2024 of the Joint Secretary to the Govt. of West Bengal, I&W Department and as per recommendation of the Departmental Tender Committee, the L1 Bidder, “Pranab Jyoti Chatterjee” is hereby debarred for a period of 06 (six) months from 09.02.2024 to 08.08.2024 from participating in all tenders of Irrigation & Waterways Department with non-issuance of any completion certificate so the bidder cannot use it for securing further works and forfeiture of his Bid-Security in terms of clause-41 of WB Form No. 2911 along with all other statutory deductions as per prevailing norms.
