**Office Order**

As the Agency named "M/S Hari Bhusan Ghosh and Co", Biswa Singha Road, Natun Bazar, PO & Dist-Coochbehar, Pin-736101, being the L1 bidder in connection with the work, "Armouring of Hanskhowa Flood Protective Embankment in between Spur No- 3 & 4 on the Left Bank of river Torsa for a length of 260 m including strengthening of nose of Spur No-3 and bank protection along the right bank of river Torsa at Ichamar-Kalpani area for a length of 360 m in GP- Madhupur ,BLOCK-Coochbehar-II PS – Pundibari Dist-Coochbehar under RIDF-XXVIII" in relation to e-NIT No.-WBIW/SE/NEIC-I/NIT-08(e) /2022-23, ,SL-01 floated on 23.03.2023, e-Tender ID no.2023\_IWD\_497797\_1, who was issued LOA. After executing formal agreement vide no.- 02(e)/SE/C of 2023-24 of the Executive Engineer, Coochbehar Irrigation Division, the agency miserably failed to start the work within the extended prescribed time and reply to the show cause was not justified and acceptable, thereby committing first Degree Offence under Sub-Clause-(ix), (x) and (xi) of Clause 11(D) of e-NIT and as for committing such offence, the penal measure of forfeiture of Earnest Money and **debarment for 02 (Two) years as per Sub-Clause (C) of clause 11(G)** of e-NIT as initiated by the concerned Superintending Engineer, North-East Irrigation Circle-I, Irrigation and Waterways Directorate Vide memo no-141/4S-525 & Dated-16.02.2024 and duly recommended by the Departmental Tender Committee (DTC) in the meeting held on 19.02.2024 ( Vide memo no-147/4S-525 & Dated-19.02.2024 of SE/NEIC-I, I & W Dte , Coochbehar) , the Agency "M/S Hari Bhusan Ghosh and Co",Biswa Singha Road, Natun Bazar, PO& Dist-Coochbehar, Pin-736101", is hereby debarred to participate in all tenders under the Administrative Department of Government of West Bengal for a period of **2 (Two) years** with effect from **22.02.2024** and the Earnest Money of the bidder stands forfeited. The Superintending Engineer, North-East Irrigation Circle-I, I & W Directorate, is hereby instructed to take necessary action to forfeit the Earnest Money deposited by the bidder with immediate effect. This order shall be brought to the notice of all concerned for strict compliance.
